#### 2024/59 Butterwick Park

The clerk confirmed she had arranged a meeting with the fabricators to discuss repairs/replacement of the footbridge. The clerk asked if Cllr Forman could also attend this meeting to give a second view on what was required. Cllr C Gosling confirmed that he had received a positive response to the Council's request for the North Sea Camp volunteers to carry out small cleaning/maintenance jobs around the park and the village.
