2022/05 Issues relating to the environment of the Parish

Traffic issues

Cllr Pearson reported an issue with a lorry which had recently been parking on Brand End Road. Due to its position, it occasionally caused an obstruction for passing traffic if a vehicle was parked on the opposite side of the road. Cllr Knowles confirmed that he had spoken to the transport company regarding the matter however, although the cab was still being parked on the road occasionally it was predominantly on the owner's driveway.

Cllr Knowles confirmed that arrangements had been made for the 'Hog Roast' to be served at 1pm on Sunday 5th June and that an application had been made to close the road from 12 noon until 8pm.
